Who needs the BIIAB APLH?

Licensing law in England and Wales states that anyone who sells or authorises the sale of alcohol to the public must hold a personal licence.

Those who wish to obtain a personal licence need to apply to their local authority.

Applicants will be asked for a number of things to support their application; one of these is proof that they hold a government approved licensing qualification such as the BIIAB APLH.

Everything you need to know to apply for a personal licence

You can rest assured that the BIIAB APLH covers everything you need to know to pass the qualification's examination and apply for your personal licence. What's more, it's been developed with experts from the industry to make sure it truly meets the needs of those who want to succeed.

The BIIAB APLH covers the syllabus set by government to enable candidates to understand the law in relation to:

- the roles, responsibilities and functions of licensing authorities within the framework of the licensing objectives
- the application process for a personal licence
- the role and legal responsibilities of the personal licence holder, and the penalties relating to failure to comply with the law
- the premises licence
- the content and purpose of operating schedules

How long does it take?

Training is supported by the BIIAB APLH handbook, or workbook, both of which are written in an easy-to-follow format and contain all the information needed to pass the exam.

All questions test the knowledge of the person taking the exam. The exam covers all aspects of the law and social responsibilities in relation to the sale of alcohol to the public. By always containing questions relating to the licensing objectives and social responsibilities, the BIIAB APLH has the **added advantage** of acting as a safeguard for the candidate's personal licence* and their business.
