



## BIIAB Level 2 Award in Drugs Awareness for Licensed Hospitality Staff (ADALHS)

### What is the BIIAB Level 2 Award in Drugs Awareness for Licensed Hospitality Staff?

This qualification has been designed to raise awareness of the illegal drugs scene and to give the learner a basic knowledge of the law relating to the use and supply of illegal drugs on licensed premises.

The ADALHS is accredited on the Qualifications and Credit Framework (QCF) at Level 2 and has a credit value of 1. The accreditation number is 501/1268/5.

## What does the ADALHS cover?

The qualification covers the following key topics:

- general drug trends and who to approach for information
- drug legislation which may affect licensed premises
- the need for multi-agency liaison and the importance of partnerships with relevant authorities
- how to initiate, implement and monitor a drug strategy (drug policy)
- how to carry out a needs assessment
- how to deal with drug users and drug dealers
- how to comply with the legal requirements in relation to drugs that are found or confiscated
- how to eliminate drugs from your premises
- how to comply with the requirements of public safety.

## Who is the ADALHS for and how will they benefit from the qualification?

The ADALHS is for anyone working in licensed premises who may be exposed to illegal drug activity, including managers and staff in:

- pubs and bars
- hotels and restaurants
- sports and social clubs
- off-licences, supermarkets and convenience stores
- nightclubs and entertainment venues.

Achieving the ADALHS will give the learner the knowledge and confidence they need to help prevent and deal effectively with any drug related problems in the premises in which they work.



## Why choose the ADALHS?

The qualification was developed with industry experts including organisations such as the Association of Chief Police Officers (ACPO), the Magistrates' Association, the Metropolitan Police, the Association of Licensed Multiple Retailers (ALMR), London Drugs Policy Forum, Pubwatch and the Association of Town Centre Management (ATCM) to ensure that learners who achieve the ADALHS fully understand the law in relation to the use and supply of illegal drugs on licensed premises.

The ADALHS is supported by a comprehensive, easy to follow handbook which covers everything that a learner needs to know to achieve the qualification. It also provides a useful ongoing reference manual.

The ADALHS is part of an established career ladder in the licensed retail sector.

If you achieve the ADALHS you will be awarded points which count towards membership eligibility of BII, the professional body for the licensed retail sector.

## What is BIIAB?

BIIAB is the dedicated awarding body for the licensed retail sector and the market leader in the development and awarding of qualifications to support the sector at all levels.
